



## Season Court Information 2026-2027

### Season Courts are for Members Only!

#### Timeline for Renewals

- **Priority renewal deadline is June 26, 2026.** If you were a season court holder in 2026-27 you have priority renewal on your court time.
- After June 16th, all current courts that have not been renewed are considered “non-renewals”, and the court will be made available for sale to the waitlist and general public.

#### Renewing Your Season Court

- **Step 1 (Captains):** Verify your intention to renew your season court by **June 26th**.
- **Step 2:** To ensure proper processing for your players, the court captain must submit the entire court roster, no later than **August 15th**.

#### Payment

- **Auto-Pay Program.** Payments will be made in four installments. First in September, then October, November, December.

#### Change of Day or Time

- If you want to change your court day and time, we will try to accommodate your wishes beginning on June 27th. All changes will be based on availability on a first come, first serve basis.

#### Tennis Ball Program

As a **FREE** service to our members we offer a new can of premium grade tennis balls to all Season Courts. You can pick them up at the front desk each time you play. We kindly ask you to return these balls by dropping them at the front desk.



## Season Court Rules 2026-2027

- Any group wishing to reserve their existing seasonal time has a right to that time until June 26, 2025. If your court time will not be offered for the 2026-27 season, you will be notified in writing.
- Cancellations & Refunds
  - You may cancel this contract without further obligation and for a full refund within three days from the date of registration.
  - After August 16, the entire court fee is non-refundable for canceled courts.
- Taconic Sport & Racquet will accept payments from individual group members only if organized by the captain and submitted with a completed "Court Roster Form" stating the individual player's names and season court share (number of plays). **Refer to Season Court Roster Template.**
- The club does not rent a "specific" court. The club rents only the day and time on any available court. Courts may be reassigned at any time at the discretion of the management.
- No outside teaching professionals are allowed to teach or use the facilities' teaching equipment.
- Management reserves the right to provide instruction or run programming on adjacent courts. This may or may not include the use of music.
- Management reserves the right to change all or part of this offering without prior notice.
- Players that are unable to play on their season court for any reason, medical or otherwise, are responsible for filling their shares of the season court. If the player that is unable to use their shares, decides to sell them to another player, the responsibility for collecting payment for those shares is their own. Taconic Sport & Racquet will not refund the original player or charge the new player for the transfer of shares. Any monetary transaction to this effect should occur directly between the two players involved.
- All Season Court Players must have a current Taconic Sport & Racquet Club Membership from the time of deposit through the end of the 2026-27 season. If at any time a season court player ends their membership at Taconic Sport & Racquet, they must sell any remaining shares in the season court.



- Non-Members are only allowed to substitute 1 time, in total across all season courts, per month without being subject to a guest fee.
- If a season court wishes to reschedule their court time on a particular week they may do so provided that the club is notified at least 24 hours in advance that the court will not be needed on the day/time to be rescheduled. If this notification is not received, no makeup will be granted. Any requests for rescheduling days and times should be made to [info@taconicracquet.com](mailto:info@taconicracquet.com) and will be subject to court availability.
- The use of the Taconic Sport & Racquet Club's facility is strictly at the player's risk. Taconic Sport & Racquet Club is not responsible for injuries, accidents or damage to any person or to personal property arising from normal athletic activities in the premises.
